This is the Redistricting Advisory Committee's 15<sup>th</sup> meeting and 9<sup>th</sup> opportunity for map drawing. On April 4<sup>th</sup> the Advisory Committee approved Committee Draft Plan 1. On May 10<sup>th</sup> the Advisory Committee approved the Final Proposed Plan pending clean up to reconcile the Advisory Committee's map with the 2022 Bexar County voter precincts. Clean up concluded at the previous meeting on May 31<sup>st</sup>.

The Advisory Committee met again on Tuesday, June 7<sup>th</sup> and made additional changes to the map impacting Brackenridge Park (voter precincts 3178 and 3207) and downtown (voter precincts 1001 and 2051). The Advisory Committee will take the Final Proposed Plan to City Council on Thursday, June 16, 2022.
